1. Agreement Overview

- Signing of breeding certificates

6. No Refund Policy

All fees paid are non-refundable under any circumstances, including but not limited to:

- Failure to conceive
- Injury, illness, or death of mare
- Changes in breeding plans

7. Live Foal Guarantee (LFG)

A “live foal” is defined as a foal that stands and nurses unassisted. If no live foal results, the Mare Owner is entitled to one (1) rebreed the following breeding season. A veterinary certificate confirming pregnancy loss must be provided. (Please note: we are very flexible on this we want you to have a foal by our stud)

8. Rebreed Conditions

- Valid for the same mare only unless approved in writing
- Booking fee applies to rebreed
- Non-transferable and non-saleable (unless you have acquired permission from Stallion Owner.

9. Embryo Transfer / Multiple Embryos

This contract applies to one (1) resulting foal only. Any embryo transfer must be declared and approved in writing. Multiple embryos or pregnancies require:

- Additional contract(s)
- Additional stud fee(s)

Failure to disclose embryo transfer or multiple embryos will void all guarantees and constitute a breach of contract.

10. Semen Shipping & Handling

- Collection days: ____ N/A 2026 ____
- Mare Owner is responsible for timing, veterinary coordination, and shipping costs.
- Prairie Dream Ranch is not responsible for delays in shipping, semen quality after it leaves the facility, improper handling, or failure to conceive.

11. Mare Requirements

- All mares must be in sound breeding condition, have current vaccinations and be free from contagious disease. *** Must have current Coggins test ***
- Prairie Dream Ranch reserves the right to require veterinary clearance and refuse any mare.

12. Assumption of Risk & Liability

Breeding and handling horses involve inherent risks. The Mare Owner agrees to assume all risks. Prairie Dream Ranch is not liable for injury, illness, or death of mare or foal. The Mare Owner is responsible for insurance if desired.

13. Registration Papers

- Breeding certificates will be signed only after full payment.
- No paperwork will be released with outstanding balances.
- Failure to pay outstanding balances may result in withholding of registration paperwork, additional fees, and collection action or legal enforcement.

14. Social Media & Promotional Rights

- Prairie Dream Ranch retains the right to use photos, videos, and information of the mare, stallion, and resulting foals for marketing, social media, advertising, and promotion.
- Mare Owner agrees to accurately represent the breeding and credit Prairie Dream Ranch and the stallion in promotions.

15. Non-Disparagement / Slander Clause

- The Mare Owner agrees not to make any false, misleading, or damaging statements regarding Prairie Dream Ranch, its owners, staff, or stallions, including on social media, public forums, and reviews.
- Violation will result in immediate termination of all guarantees (including LFG), refusal of future services, and potential legal action for damages.

16. Governing Law

This Agreement shall be governed by the laws of the Province of Manitoba and the laws of Canada applicable therein.

17. Entire Agreement

This document represents the entire agreement between both parties. No verbal agreements shall be recognized.
